



Canada's actions are in violation of Vienna Convention, says Jaishankar



- Canada's inability to provide safety and security to indian diplomats challenges the "most fundamental aspect" of the Vienna Convention on Diplomatic Relations, External Affairs Minister S. Jaishankar said
  - India insists that its actions are consistent with the tenets set forth in Article 11.1 of the Vienna Convention on Diplomatic Relations. This particular segment pertains to the size of international missions within other countries.
- The Vienna Convention on Diplomatic Relations is an international treaty signed by 61 countries in 1961.
  - At present 193 countries are party to the document.
- The Vienna Convention provides a complete framework for the establishment, maintenance and termination of diplomatic relations on a basis of consent between independent sovereign States.
- Under the Vienna Convention a diplomatic agent enjoys immunity from the criminal jurisdiction of the receiving State. Such individuals are also provided with immunity from its civil and administrative jurisdiction – with a few exceptions.



AQI	Remark	Color Code	Possible Health Impacts
0-50	Good		Minimal impact

101-200	Moderate		Breathing discomfort to the people with lungs, asthma and heart diseases
201-300	Poor		Breathing discomfort to most people on prolonged exposure
301-400	Very Poor		Respiratory illness on prolonged exposure
401-500	Severe		Affects healthy people and seriously impacts those with existing diseases

- Hatti community living in the Trans-Giri region of Himachal Pradesh's Sirmaur district.
  - Rajya Sabha on July 26 2023 passed a bill to accord the Scheduled Tribe status to the Hattee community.

#### **Criteria for Inclusion of Tribes**

- Scheduled Tribes have been defined in clause (25) of article 366 of the Constitution as such tribes or tribal communities or parts of or groups within such tribes or tribal communities as are deemed under article 342 to be Scheduled Tribes for the purposes of the Constitution.
- The process to include tribes in the ST list begins with the recommendation from the respective State governments, which are then sent to the Tribal Affairs Ministry, which reviews and sends them to the Registrar General of India for approval. This is followed by the National Commission for Scheduled Tribes' approval before the list is sent to the Cabinet for a final decision.

While wages and earnings have increased, inflation has also increased. If inflation is higher than the growth of earnings, real earnings reduce

- Recent data from the Periodic Labour Force Survey (PLFS of 2022-23 revealed a strengthening of the labour market, with unemployment rates falling and labour force participation rates (LFPRs) rising.
- Rural women's LFPRs for those aged 15 and above rose from 19.7% in 2018-19 to 41.5% in 2022-23, a significant jump for a cohort that had long been on the margins of the labour market.
  - These results were taken as examples of a robust post-pandemic recovery for the Indian economy.
- The share of the rural female workforce in paid forms of self-employment rose from 22% to 28% between 2018-19 and 2022-23,
  - There has been a rise in the proportion of women working as unpaid family helpers, with the share of rural working women in this form of employment rising from 37.9% to 43% between 2018-19 and 2022-23.
- Between 2019 and 2023, only casual workers both men and women, across both rural and urban sectors saw a net increase in their average real monthly earnings.

# To curb evasion, EU report calls for 2% global wealth tax on billionaires

It will generate \$250 bn from less than 3,000 individuals; report highlights success of automatic exchange of bank data in reducing offshore tax evasion; it raises concern over rise of preferential tax regimes targeting wealthy foreign individuals

- European Union Tax Observatory in its 'Global Tax Evasion Report 2024' has called for a global minimum tax on billionaires equal to 2% of their wealth.
  - This would both address evasion and "generate nearly \$250 billion from less than 3,000 individuals",
  - The report justified the proposal by noting that while the number of taxpayers affected by it would be miniscule, the tax rate for them (2%) "would still be very modest" given that the wealth of billionaires has grown at 7% a year annually on average since 1995 (net of inflation).

- The bilateral trade between India and the US rose 7.65 per cent to USD 128.55 in 2022-23 against USD 119.5 billion in 2021-22. It was USD 80.51 billion in 2020-21.
