- Under the mission, basic facilities such as road and telecom connectivity, electricity, safe housing, clean drinking water and sanitation, improved access to education, health and nutrition and sustainable livelihood opportunities will be provided to PVTG habitations, which are mostly remote, scattered and inaccessible

Do you know?

It was in 2004 that UNESCO launched the Creative Cities Network to promote cooperation among cities that have identified creativity as a strategic factor for sustainable urban development.

- Edinburgh was the first City of Literature.
- Besides literature, the UN agency also recognises cities for their association with other creative fields like film, crafts, folk arts and design. This year, Gwalior has been named a City of Music, an honour that was achieved before by two other Indian cities, Varanasi (2015) and Chennai (2017). A city has to submit a bid explaining why it deserves to be considered.

Proposed criminal code gives more immunity to defence personnel



The Bharatiya Nagarik Suraksha Sanhita (BNSS) Bill, 2023, expected to replace the Code of Criminal Procedure (CrPC), provides further immunity to armed forces personnel as no case can be registered against them without the sanction of the Union or the State government for acts performed in the line of duty.

• The proposed provision will be in addition to the Armed Forces Special Powers Act (AFSPA) that gives unbridled power to the armed forces deployed in "disturbed areas" to arrest or kill anyone acting in contravention of law, and search any premises without a warrant, and protection from prosecution and legal suits without Central government's sanction. At present, the AFSPA is applicable in parts of Assam, Arunachal Pradesh, Nagaland, Manipur, and whole of Jammu and Kashmir.

Do you know?

 The CrPC, introduced in 1898 and amended in 1973, provides protection to members of the armed forces only from arrest and there are no conditions regarding registration of a criminal case.


FATF team in India to hold on-site review meetings



- The Financial Action Task Force (FATF) was established in PS
 1989 by the G7 to examine and develop measures to
 combat money laundering. It originally included the G7
 countries, the European Commission and eight other
 countries.
- The FATF was given responsibility to examine money laundering techniques and trends, review the action already taken at a national or international level, and to set out measures needed to combat money laundering. In 2001, the FATF expanded its mandate to also combat terrorist financing.
- Since 2019, the FATF has had an open-ended mandate, after originally operating under fixed-terms.

NASA, ISRO prepare to launch joint space mission



- NASA-ISRO SAR (NISAR) is a Low Earth Orbit (LEO)
 observatory being jointly developed by NASA and ISRO.
- NISAR will map the entire globe in 12 days and provide spatially and temporally consistent data for understanding changes in Earth's ecosystems, ice mass, vegetation biomass, sea level rise, ground water and natural hazards including earthquakes, tsunamis, volcanoes and landslides. NISAR.
 - It carries L and S dual band Synthetic Aperture Radar (SAR).
 - Synthetic aperture radar (SAR) refers to a technique for producing fine-resolution images from a resolution-limited radar system.

India, US, 12 other IPEF members sign supply chain resilience agreement

The 14 countries that are part of IPEF include India, Australia, the US, Japan, Fiji, Korea, New Zealand, Singapore and Thailand, and make up for 40% of global gross domestic product and about a third of global goods and services trade.

- India, the US and 12 other members of the Indo-Pacific
 Economic Framework (IPEF) on Wednesday entered into
 a supply chain resilience agreement that aims to cut
 dependence on China and help shift manufacturing of
 crucial goods to member nations.
- The 14 countries that are part of IPEF include India, Australia, the US, Japan, Fiji, Korea, New Zealand, Singapore and Thailand, and make up for 40% of global gross domestic product and about a third of global goods and services trade.
- The IPEF is structured around four pillars relating to trade, supply chains, clean economy and fair economy (issues like tax and anti-corruption). India has joined all the pillars except the trade pillar.
