Selective confidentiality in electoral bonds may not suffice: SC

 The Supreme Court said the problem with electoral bonds scheme is that it provides for "selective anonymity" and "selective confidentiality" as the details are available with the State Bank of India (SBI) and can also be accessed by the law enforcement agencies.

NEXT

- The Government of India has notified the Electoral Bond Scheme 2018 vide Gazette Notification No. 20 dated 2nd January 2018 (as amended vide Gazette Notification dated 7th November, 2022).
- Electoral Bond is a bearer instrument in the nature of a Promissory Note and an interest free banking instrument.
- A citizen of India or a body incorporated in India will be eligible to purchase the bond.
- Political Parties registered under Section 29A of the Representation of the People Act, 1951 (43 of 1951) and which secured not less than one per cent of the votes polled in the last General Election to the House of the People or the Legislative Assembly of the State, shall be eligible to receive the Electoral Bonds. The Electoral Bonds shall be encashed by an eligible Political Party only through a Bank account with the Authorized Bank.

Centre to depute national level monitors to oversee livestock schemes

As per the appointment terms of reference for National Level Monitors (NLM), two types of monitoring will be conducted by them — regular and special.

- The Centre has decided to deploy National Level
 Monitors (NLM) to oversee the implementation of its
 livestock schemes including National Livestock Mission
 and Rashtriya Gokul Mission.
- The NLMs will be third-party independent monitors —
 individuals and institutions deployed by the government.
 Individual NLMs will be selected from among retired
 Civil/Defence Services Officers, and academia.

Do you know?

The contribution of livestock sector in agriculture in terms of output, has increased from 24.32 per cent (2014-2015) to 30.87 per cent (2020-21). The Livestock sector has been growing at a compounded annual growth rate of 7.93 per cent (at constant prices) from 2014-15 to 2020-21

Rooster drones set to be handed over to Army's Northern Command tomorrow

The features of these drones enable them to gather critical intelligence and conduct surveillance missions in urban areas, dense forests, and mountainous regions, where rolling proves advantageous.

- Rooster drones, indigenously developed devices that can roll as a robot and fly as a drone, will be handed over to the Northern Command of the Indian Army at an event at Gandhinagar-based Rashtriya Raksha University (RRU)
- The drone draws its name from roosters that spend most of their time on the ground. They can also fly and perch atop a building or a tree. Each drone is enclosed in a frame which helps it not only in taking off vertically and land, but also roll on the ground. It also has cameras, and can land on top of a building or a window sill and quietly capture the details. So it is more useful than its counterparts like a quadcopter,

India's own CAR-T cell therapy: What is it, when will it be available, and at what cost?

The drugs regulator has granted market authorisation to India's breakthrough CAR-T cell therapy for patients with B-cell lymphomas who didn't respond to standard treatments like chemotherapy.

- The Central Drugs Standard Control Organisation
 (CDSCO) this month granted market authorisation for
 NexCAR19, India's first indigenously-developed CAR-T
 cell therapy, to ImmunoACT, a company incubated by IIT
 Bombay.
 - This paves the way for the commercial launch of this therapy in India, where it is expected to be available to cancer patients at a tenth of the cost abroad.

Do you know?

CAR-T is a revolutionary therapy that modifies immune cells, specifically T-cells, by **turning them into potent cancer fighters** known as CAR-T cells. T-cells are special cells (white blood cells that find and fight illness and infection) whose primary function is cytotoxic, meaning it can kill other cells. In CAR-T therapy, we genetically modify them into cancerfighting cells. These supercharged cells are then put back into the body, and they go after cancer cells — especially in blood cancers like leukaemia and lymphomas.

Novel therapeutic formulation developed for improved treatment of Indian red scorpion sting

- A new therapeutic drug formulation (TDF) comprising of low doses of commercial equine anti-scorpion antivenom (ASA), α1- adrenoreceptor agonist (AAAs) and vitamin C, for inhibiting the Indian red scorpion venom-induced toxicity and associated symptoms can help improve clinical management of scorpion sting patients.
- Scorpion envenomation is a severe problem in many countries of the world.

Do you know?

• The Indian red scorpion (*Mesobuthus tamulus*), with its life-threatening sting, is one of the world's most dangerous scorpions.
