## Cases of human trafficking victims being forced to commit cybercrimes on the rise

The first Interpol operation against fraud schemes fuelled by victims of human trafficking has unearthed further evidence that the trend is expanding beyond the southeast Asian region. Indian enforcement agencies also participated in the exercise.

The fraud schemes included fake cryptocurrency investments, fraudulent work-from-home offers, and lottery and online gambling scams.

Known as "Operation Storm Makers II", the Interpol exercise resulted in the arrest of 281 persons in different countries, on charges such as human trafficking, passport forgery, corruption, telecommunications fraud, and sexual exploitation.

While 149 human trafficking victims were rescued, over 360 investigations were opened, several of which are still being pursued by law enforcement agencies.

According to Interpol, the Telangana police registered one of the first cases in India of human trafficking committed to force victims to commit cyberfraud. As it turned out, an accountant was lured to a southeast Asian country, where he was made to participate in online fraud schemes and subjected to inhuman conditions. He was able to leave following the payment of a ransom.

In August, a UN Human

Rights Office report took up the issue and found that the frauds ranged from romance-investment scams and cryptofraud to illegal gambling.

"Victims face a range of serious violations and abuses, including threats to their safety and security; and many have been subjected to torture and cruel, inhuman and degrading treatment or punishment, arbitrary detention, sexual violence, forced labour, and other human rights abuses," the UN report said.

"Credible sources indicate that at least 1,20,000 people across Myanmar may be held in situations where they are forced to carry out online scams, with estimates in Cambodia similarly at around 1,00,000. Other States in the region, including Lao PDR, the Philippines and Thailand, have also been identified as main countries of destination or transit where at least tens of thousands of people have been involved," the report added, noting that the scam syndicates generated annual revenues amounting to billions of dollars.

"Most people trafficked into the online scam operations are men, although women and adolescents are also among the victims," it said.

In October, Ugandan law enforcement had reported that several citizens were taken to Dubai on the promise of jobs and then to Myanmar via Thailand.

#### 21.15 lakh applications received under PM Vishwakarma Scheme, says Skill Ministry

The PM Vishwakarma Scheme, launched by the Centre on September 17, nas received over 21 lakh applications in two-and-ahalf months, data from the Ministry of Skill Developnent and Entrepreneur ship (MSDE) show. The scheme, aimed at supporting and providing skill-upgrade training to artisans and craftspeople, was announced by Prime Minister Narendra Modi.

The highest number of applications had come rom Karnataka (6.28 lakh), followed by West Bengal (4.04 lakh), Assam (1.83 lakh), Uttar Pradesh (1.53 lakh) and Andhra Pradesh (1.21 lakh). In contrast, 15 States including Harvana, Kerala, Chhattisearh, Himachal Pradesh, Jttarakhand, and northeastern States have sent fewer than 10,000 applications each.

Mr. Tewari further added that while lakhs of persons have applied across the country, they are being vetted at three levels - by village committees and district and State levels.

"As of December 1, 17,758 candidates are ready to undergo training from 21 States. The target is to cover six lakh beneficiaries in FY 2023-24," Mr. Tewari said. Of these, Karnataka has verified 7,924 candidates, followed by Assam (4,980), Andhra Pradesh (2,737), Uttar Pradesh (1,033). "After the appli-

cants are thoroughly vet ted, they will attend basic training of five to seven days and advanced train ing of 15 days with a stipend of ₹500 per day that will expose them to mod ern tools, latest technolo gies, design elements, and digital and financial skills, Mr. Tewari said. The budget envisage

for the scheme from finan cial year 2023-24 to 2027-28 is ₹13,000 crore. While 4.04 lakh candidates have applied from West Bengal the State has not put in place village-, district- and State-level committees fo vetting candidates yet, offi cials said.

## Sudan declares 15 diplomats of UAE *persona non grata*

Sudan's Foreign Ministry declared 15 UAE diplomats persona non grata on Sunday, demanding they leave Sudan "within 48 hours".

In recent weeks, pro-Army demonstrators and officials loyal to Army chief Abdel Fattah al-Burhan have accused the United Arab Emirates of supporting the paramilitary Rapid Support Forces, led by Burhan's former deputy Mohamed Hamdan Daglo. The two forces have been at war since April 15, killing

12,000 people and displacing seven million.

#### Benefiting parties

World leaders including UN Secretary-General Antonio Guterres have said unnamed actors supplying "financial and weapons" support to both warring sides have contributed to the ongoing carnage.

While Egypt and Turkey have stood firmly in the army's corner, the UAE has been accused of funnelling arms and support to the RSF, which controls much of the country's lucrative gold mining sector.

#### Pinna nobilis: Comeback hero

A huge clam that was on the verge of extinction has made a comeback, with a surge in numbers in waters off Croatia, marine biologists say. The clam, known as the noble pen shell or pinna nobilis, started dying out as a deadly pathogen spread in parts of the Mediterranean around 2016. Numbers plummeted across the region and, until recently, scientists in Croatia only knew of around 10 surviving in their corner of the Adriatic.

Last year, a diver spotted a group of 20 near the shore in the north of the Istria peninsula. "The news sounded incredible. It was impossible they were alive," said Sandro Dujmovic of the Natura Histrica organisation, which manages Istria's protected areas.

This year biologists managed to collect about 100 young specimens and take them to an aquarium. "It was a sign that they are still reproducing

Adriatic town of Pula, they are kept in specially filtered water, clear of the parasites that can attack them.

The scientists said it was too early to say what had caused the comeback, but Croatia's government was funding more research.

# Article 370 verdict today: What other decisions by the Centre it will impact

From delimitation in Jammu and Kashmir to voting rights to West Pakistan Refugees, a host of decisions will be impacted by the SC verdict on pleas challenging the changes made to Article 370. Here are the crucial ones

- On August 5, 2019, the President issued the Constitution (Application to Jammu and Kashmir) Order which inserted a new provision, Article 367(4), in the Indian Constitution. This replaced the expression 'Constituent Assembly of the State' in the proviso to Article 370(3) with 'Legislative Assembly of the State'.
- The same day had seen the Rajya Sabha abrogate Article 370 and pass the Bill to reorganise the State of Jammu and Kashmir. The next day had seen the Lok Sabha pass the Bill and the President declare that Article 370 had ceased to apply.
  - Article 370: (Special status of Jammu and Kashmir): Article 370 gave special status to Jammu and Kashmir in the Indian Union and restricted the Centre's legislative powers with respect to the state. It gave the state legislature special powers to draft its own Constitution. Article 35-A: Article 35-A was introduced into the Constitution through Article 370. Article 35-A empowered the Jammu and Kashmir state legislature to define the permanent residents of the state and their special rights and privileges.
