Life through geometry in Warli

Warli Whisperers by the Inherited Arts Forum traces the artistic journey of the Mashe family from Maharashtra

he triangles, circles and lines in austere white against a mud brown background align to tell stories of village life and their customs and traditions on walls and canvasses. Warli represents the daily routine of rural life, the relationship of the tribal people with Nature, their gods, myths, traditions, customs, and festivities.

"Warli is our life and our life is Warli," says Vijay Soma Mashe, a third-generation include some rare paintings by the late Jivya Soma Mashe, his sons Balu Jivya Mashe and Sada Shiv Jivya Mashe.

"Warli flows in our DNA", says Vijay, talking of his grandfather Jivya who introduced varied themes in the art form and took it from the walls of mud houses to the canvas. The celebrated Mashe family belongs to Ganjad village in the Palghar district of Maharashtra. Jivya Soma Mashe is known as the father of Warli art because he pulled it out of the traditional domain and popularised it beyond the

- Warli tribals of Thane district in Maharashtra decorate
 their house walls with paintings depicting their lives:
 planting saplings, carrying grain, dancing, travelling to
 market and other routine activities of their daily lives.
 Symbols of the sun, moon and stars along with plants,
 animals, insects and birds show their belief in the
 integration of all forms of life.
- On ritual and ceremonial occasions Warli home walls are plastered with dung. Rice paste is used with red ochre powder to tell stories and to invoke the blessings of their goddess of fertility, Palaghata.

SC Collegium recommends CJs to five High Courts

The Supreme Court Collegium headed by Chief Justice of India D.Y. Chandrachud has recommended the appointment of Chief Justices to five High Courts.

Justice Manindra Mohan Shrivastava has been proposed for appointment as the Chief Justice of Rajasthan HC. Justice Sheel Nagu has been recommended for appointment as the Chief Justice of HC of Punjab and Haryana.

It has suggested the appointment of Justice Vijay Bishnoi as the Chief Justice of the Gauhati HC. Justice Arun Bhansali has been proposed for the Chief lus-

- The collegium of the CJI and four senior-most judges of the Supreme Court make recommendations for appointments to the apex court and High Courts.
- The collegium can veto the government if the names are sent back by the latter for reconsideration.
- The basic tenet behind the collegium system is that the judiciary should have primacy over the government in matters of appointments and transfers in order to remain independent.

Do you know?

The appointment of the CJI and judges of the apex court is governed by a Memorandum of Procedure. The CJI and the judges of the Supreme Court are appointed by the President under clause (2) of Article 124 of the Constitution.

COVID-19-hit MSMEs can tap new relief window from Jan. 1

Finance Ministry to accept claims under Vivad Se Vishwas I scheme, five months after original deadline passed; allows three-month window



- Starting January 1, 2024, MSMEs can submit fresh claims under the Vivad Se Vishwas I scheme, which had originally admitted claims between mid-April to end of July this year.
- Announced by Finance Minister Nirmala Sitharaman in the Union Budget 2023-24, Vivad Se Vishwas (VSVS) I scheme was aimed at providing relief to MSMEs unable to comply with central government contracts due to the pandemic.
- it covered all procurement contracts related to goods, services and works entered into by government departments.
- A similar VSVS II scheme was launched to resolve pending contractual disputes related to public procurement.

Nina Singh 1st woman to head CISF, Anish Dayal new CRPF chief

THE CENTRE on Thursday appointed Nina Singh as the Director General of CISF, making her the first woman to head this elite force. Apart from her, the Centre has also appointed ITBP chief Anish Dayal Singh as the Director General of the Central Reserve Police Force (CRPF).

"Nina Singh has been appointed as the DG, CISF. Singh, a 1989-batch IPS officer of Rajasthan cadre, is currently working as Special DG, CISF. She has been appointed to the post till her superannuation on July 31, 2024," the order said.

Nina Singh was the first woman IPS officer allocated to the Rajasthan cadre where she served in many important assignments across the state. She also worked as Joint Director in the CBI during 2013-18 where she supervised many high-profile cases having national and international ramifications.


