On equal access to benefits for all SCs

Why has a high-level committee been formed post Prime Minister Narendra Modi's promise to the Madiga community in Telangana? What has the community been demanding since 1994? Can Parliament sub-categorise castes within the Scheduled Castes?



- The Union government has formed a high-level committee of secretaries, chaired by the Cabinet Secretary, to evaluate and work out a method for the equitable distribution of benefits, schemes and initiatives to the most backward communities among the over 1,200 Scheduled Castes (SCs) across the country, that have been crowded out by relatively forward and dominant ones.
- Prime Minister Narendra Modi chaired in December, 2023, weeks after promising to look into the demand for sub-categorisation of Scheduled Castes as raised by the Madiga community in Telangana in the run-up to the Assembly elections there last year.
 - The Madiga community constitutes at least 50% of the SC population in Telangana, where SCs comprise around 15% of the total population (2011 Census).

Govt. expands financial services scope at IFSC

The government has expanded the scope of activities that can be undertaken at the International Financial Services Centre (IFSC) by including services such as book keeping, and accounting.

As per a notification from the Finance Ministry, many services, including book-keeping, accounting, taxation, and financial crime compliance, have been included as part of financial services.

"Provided that the financial services shall be offered by units in an International Financial Service Centre regulated by the International Financial Services Centres Authority (IFSCA) to non-residents whose business is not set up either by splitting up of business already in existence in India; or reconstructing/reorganising of business already in existence in India," it said in a notification on January 18.

The notification stipulates the units should not offer services by way of transferring or receiving existing contracts or work arrangements from their group entities in India.

 (IFSCA) has been established on April 27, 2020 under the
 International Financial Services Centres Authority Act,
 2019. It is headquartered at GIFT City, Gandhinagar in
 Gujarat.

Jammu CSIR lab finds cannabis compound that has antibiotic effects

CSIR-IIIM Jammu researchers have found a compound, THCBD, to have potent antibiotic effects against against *Staphylococcus aureus*, a bacteria responsible for the second most number of deaths due to antimicrobial resistance, whereby microbes stop responding to medicines, worldwide



- Cannabis has the potential to make a dent in India's fight sagainst the escalating threat of antibiotic resistance.
- Scientists at CSIR-Indian Institute of Integrative Medicine (IIIM), Jammu, have found that phytocannabinoids, a class of compounds found in the cannabis plant, possess some hitherto unexplored antibiotic properties.
- Antimicrobial resistance (AMR) is a major health concern worldwide. It refers to when bacteria, viruses, fungi, and parasites no longer respond to medicines used to treat them.
- According to one estimate, India reported 2.97 lakh deaths in 2019 that could be attributed to AMR and 10.42 lakh others that could be associated with AMR.

World's biggest iceberg battered by waves as it heads north





- The world's largest iceberg, named A23a, seen in Antarctica
- The iceberg named A23a is nearly more than twice the size of Greater London. After decades stuck to the Antarctic ocean floor, it is now heading north on what could be its final journey
- It contains an estimated one trillion tonnes of freshwater that is likely to melt off into the ocean along the way.
- The iceberg, which is up to 400 metres thick in places, is currently drifting between Elephant Island and the South Orkney islands.

India-Myanmar border will be fenced like that of Bangladesh, Centre reconsidering Free Movement Regime: Amit Shah

With the end of the Free Movement Regime (FMR) and the fencing of the border, it will be mandatory for anyone coming into India from across the border to get a visa.



- Union Home Minister Amit Shah on Saturday announced that the Centre has decided to fence the entire length of the currently porous India-Myanmar border to stop free movement of people.
- The FMR with Myanmar, formalised in 2018 following the agreement between India and Myanmar on land border crossing, allows tribes living along the border on either side to travel up to 16 km inside the other country without a visa and stay up to two weeks.

Do you know?

 India shares a 1,643 km-long border with Myanmar, which passes through the States of Arunachal Pradesh (520 km), Nagaland (215 km), Manipur (398 km), and Mizoram (510 km).
