10th century Kadamba inscription written in Kannada and Sanskrit found in Goa



 An inscription written in Kannada and Sanskrit and said to be of 10th century A.D. Kadamba period has been discovered in the Mahadeva temple at Cacoda in southern Goa.

Do you know?

- the Kadambas of Goa were the subordinates of Chalukyas of Kalyana.
- Chalukyan emperor Tailapa II appointed Kadamba
 Shasthadeva as mahamandaleshwara of Goa for his help in overthrowing the Rashtrakutas.
- Kadamba Shasthadeva conquered the city of Chandavara from the Shilaharas in 960 A.D.
- Later, he conquered the port of Gopakapattana (present Goa).
- Gundayya, the son of Talara Nevayya, may have participated in this battle, and won the port at the cost of his life.
- His father may have erected a memorial stone with the inscription in the temple of Mahadev of Cacoda to commemorate the heroic fight of his son.

Election Commission tweaks rules for allocation of symbols to new parties

- The Election Commission of India (ECI)brought in new rules for the allocation of symbols to registered unrecognised political parties (RUPPs), making it mandatory for them to furnish audited accounts of the last three financial years, expenditure statements of the last two elections, and the signature of the authorised office-bearer of the party along with the application form for symbols.
 - The new rules would come into effect from January 11.

Do you know?

- RUPPs are either newly-registered parties those which have not secured enough percentage of votes in the Assembly or general election to become a State party, or those that have never contested elections after being registered.
- Common symbols are provided to RUPPs based upon an undertaking that they would put up "at least 5% of total candidates with regard to said Legislative Assembly election of a State".

ISRO to perform crucial manoeuvre tomorrow to bind Aditya-L1 into L1 orbit

With the Aditya-LI spacecraft expected to reach the Lagrangian Point (LI) on Saturday, the Indian Space Research Organisation (IS-RO) will attempt a crucial manoeuvre to bind the spacecraft to an orbit around L1.

Aditya-L1, the first Indian space-based observatory to study the sun, was launched on September 2, 2023 from the Satish Dhawan Space Centre in Sriharikota. Subsequently, ISRO Telemetry Tracking and Command Network (IS-




From Earth: A satellite placed in halo orbit around L1 point has the advantage of viewing the Sun without any eclipse. S R RAGHUNATHAN

cial manoeuvre which will bind Aditya-LI to an orbit around LI.

The propulsion system of the spacecraft comprisvide a greater advantage of observing the solar activities continuously.

Aditya-L1 carries seven payloads to observe the

- Aditya-L1, the first Indian space-based observatory to study the sun, was launched on September 2, 2023 from the Satish Dhawan Space Centre in Sriharikota.
- Subsequently, ISRO Telemetry Tracking and Command Network (ISTRAC) in Bengaluru carried out four earthbound manoeuvres between September 3 and 15 last year.
- L1 is about 1.5 million km from earth and the distance of L1 from the planet is approximately 1% of the earth-sun distance.

New antibiotic could target drug-resistant bacterium: scientists

- Researchers have identified a new class of antibiotics with the potential to tackle a drug-resistant bacterium, *Acinetobacter baumannii*.
- Zosurabalpin, the antibiotic, was found to be effective against CRAB (carbapenem-resistant *Acinetobacter* baumannii)-induced pneumonia and sepsis in mouse models.

Do you know?

- CRAB is classified as a priority 1 (critical) pathogen by the World Health Organization (WHO), alongside two other drug-resistant forms of bacteria – Pseudomonas aeruginosa and Enterobacteriaceae.
- Priority pathogens is a catalogue of 12 families of bacteria released by WHO, that pose the greatest threat to human health

Arvind Kejriwal, Hemant Soren refuse ED summons: What happens now

Can Arvind Kejriwal and Hemant Soren be arrested for failing to appear before the ED after receiving a summons? What are the provisions under which the ED issues summons? How have courts viewed the matter?



What are the provisions for issue of summons?

- Summons for interrogation are issued by ED under Section 50 of the PMLA. According to the provision the Director of the ED, for the purposes of investigations, has the power of civil court for inspection, enforcing attendance of a person, compelling the production of record, receiving evidence on affidavits etc.
- According to the provision, "The Director, Additional Director, Joint Director, Deputy Director or Assistant Director shall have power to summon any person whose attendance he considers necessary whether to give evidence or to produce any records during the course of any investigation or proceeding under this Act", and "all the persons so summoned shall be bound to attend in person or through authorised agents" as the ED officer may direct them to do.

! What if the person refuses to appear?

 The law has provision for penalty of up to Rs 10,000 and invocation of Section 174 of the Indian Penal Code that stipulates a jail term of one month and/or a fine of Rs 500 in case of non appearance against ED summons.
