What is MSP?

- It is the price at which the government offers to procure farmers' produce during the season.
- It was first introduced in the 1965-66 season for wheat. Later the coverage was expanded to coarse cereals.
- It aims to provide a fair return to farmers and to protect the interests of consumers.
- The Cabinet Committee of Economic Affairs announces the MSP at the start of each sowing season, taking into account the recommendations of the Commission for Agricultural Costs and Prices (CACP).
- The key considerations, while recommending the MSP for crops, are demand and supply, production cost, price trends in the domestic and international market and the likely implications of the price on consumers.

Clause in draft India-EFTA pact may hit drug industry

A clause in a draft free trade agreement text being negotiated between India and the European Free Trade Association (EFTA) – Switzerland, Iceland, Lichtenstein and Norway – could delay access to affordable, generic versions of patented drugs in India by a minimum of six years, according to documents viewed by The Hindu.

- The European Free Trade Association (EFTA) is the intergovernmental organisation of Iceland, Liechtenstein, Norway and Switzerland.
 - It was set up in 1960 for the promotion of free trade and economic integration between its members.
- The India EFTA text is a broad-ranging agreement that is being negotiated between India and the four countries since 2008 to increase investment by these countries in India and reduce tariffs, on a range of exports from these countries.

- The Forest Rights Act (FRA), 2006 recognizes the rights of the forest dwelling tribal communities and other traditional forest dwellers to forest resources, on which these communities were dependent for a variety of needs, including livelihood, habitation and other sociocultural needs.
- The Act encompasses Rights of Self-cultivation and Habitation which are usually regarded as Individual rights; and Community Rights as Grazing, Fishing and access to Water bodies in forests, Habitat Rights for PVTGs, access to biodiversity, community right to intellectual property and traditional knowledge, recognition of traditional customary rights

Do you know?

Sanctuaries and national parks are notified under the Wildlife (Protection) Act (WLPA) 1972. People inside sanctuaries continue to enjoy all their rights unless prohibited, but they don't in National Parks. No new rights are permitted once the notice of intent is issued. The Collector is to inquire into the rights of all persons, their nature and extent, in the proposed sanctuary or national park.

Govt. eyes expansion of HSN codes for rice to limit expocurbs



- HSN stands for Harmonised System of Nomenclature code.
- This was introduced in 1988 by the World Customs
 Organization (WCO). This was introduced for a systematic
 classification of goods both national and international.
- This is a 6-digit code that classifies various products.
- India has been using HSN **codes** to classify commodities for Customs and Central Excise.
- There are different HSN codes for various commodities.
 HSN codes remove the need to upload details about the goods which makes filing of GST returns easier.

What did Trump say about NATO funding and what is Article 5?

Former US President Donald Trump has once again attacked NATO. Why? What is NATO? How is it funded?

- NATO promotes democratic values and enables members to <u>consult</u> and cooperate on defence and security-related issues to solve problems, build trust and, in the long run, prevent conflict.
- NATO is committed to the peaceful resolution of disputes. If diplomatic efforts fail, it has the military power to undertake <u>crisis-management</u> operations.
- These are carried out under the collective defence clause of NATO's founding treaty – <u>Article 5 of the Washington</u> <u>Treaty</u> or under a United Nations mandate, alone or in cooperation with other countries and international organisations.
- NATO currently has 31 members most of them
 European nations, plus the United States and Canada.
- The newest member is Finland, which joined last April in reaction to Russia's 2022 invasion of <u>Ukraine</u>. Sweden applied to join along with Finland but is waiting for Hungary to ratify its application as the final major step before membership.
