Centre's reply sought on the age limit for surrogacy

NEW DELHI

The Delhi High Court on Wednesday sought the Centre's response within four weeks on a petition by a couple challenging the law that allows only women aged between 23 and 50 to go for surrogacy.

The couple, both aged around 51, contended that such a restriction is against their right to procreation.

While asking the Centre to file its reply, the court remarked that "no one can sit on judgment" in such cases. The **Surrogacy (Regulation) Act** defines surrogacy as a practice where a woman gives birth to a child for an intending couple with the intention to hand it over to them after the birth. It is permitted only for altruistic purposes or for couples who suffer proven infertility or disease. Surrogacy is prohibited for commercial purposes including for sale, prostitution or any other forms of exploitation.

Who can avail of surrogacy?

- The couple is deemed 'eligible' if they have been married for five years, the wife is aged between 25-50 years and the husband is between 26-55 years.
- The couple must not have any living child (biological, adopted or surrogate.)

Who can be a surrogate?

A surrogate mother has to be a close relative of the couple, a married woman with a child of her own, aged between 25-35 years, who has been a surrogate only once in her life. She must also possess a certificate of medical and psychological fitness for surrogacy

RBI issues fiat on BPSP card transactions



- RBI has asked card networks such as Visa and Mastercard to stop commercial card transactions under Business Payment Solution Providers (BPSP) business, on concerns regarding legitimacy and inadequacy of merchant KYC and end use of funds.
- BPSP allows small businesses to accept card payments without having the required mechanisms in place. For example, a large business can make payments to its smaller suppliers using this mechanism even though the latter does not have the infrastructure for accepting credit payments. While BPSPs are regulated and licensed by RBI under the PA-PG (Payment Aggregators and Payment Gateways) guidelines, there are concerns on transactions being carried out without proper invoicing or KYC, making it difficult to track the source of money and where it is going.

Supreme Court to deliver verdict on validity of electoral bonds scheme today

The scheme was announced in the 2017 Union Budget speech when Late Arun Jaitley was the Finance Minister. Electoral bonds are interest-free bearer instruments that are essentially used to donate money anonymously to political parties.

- <u>Electoral bonds</u> are interest-free bearer instruments that are essentially used to donate money anonymously to political parties.
- The bonds are sold in multiples of Rs 1,000, Rs 10,000, Rs 1 lakh, Rs 10 lakh, and Rs 1 crore, and State Bank of India is the only bank authorised to sell them. Donors can buy and subsequently donate bonds to a political party, which can encash the bonds through its verified account within 15 days.
- There is no limit on the number of bonds an individual or company can purchase.
- Only the Political Parties registered under Section 29A of the Representation of the People Act, 1951 (43 of 1951) and which secured not less than one per cent of the votes polled in the last General Election to the House of the People or the Legislative Assembly of the State, shall be eligible to receive the Electoral Bonds.

The Indian Space Research Organisation (ISRO) will launch the INSAT-3DS from Sriharikota on February 17.

2,274kgs and funded by the Ministry of Earth Sciences, will enable the development of newer satellite products that can be deployed while tracking cyclones, monsoon systems, thun-

derstorms and other natural disasters. INSAT-3DS shall further the observations of atmosphere, land and oceans.

The INSAT-3DS is a continuation to the Third Generation Meteorological Satellite series cilitated with improved satellite from the geostationary orbit. Presently, meteorologists make extensive use of data generated soon-to-belaunched INSAT-3DS. by satellites like the INSAT-3D and INSAT-3DR (launched in September, 2016, still opera-

Since 2003, the India This new facility, weighing Meteorological Department (IMD) has been using INSAT data for its operational meteorology purposes. The advent of satellitebased products brought significant improvements in the forecast accuracy, monitoring of

atmosphere and ocean parameters and overall enhanced the meteorological services leading to reduction in loss to property, life and livelihood.

In all, INSAT-3DS comprises four payloads -- an Imager, a Sounder, a Data Relay Transponder and a Satellite aided Search and Rescue Transponder. The multi-spectral imager will generate images of the Earth across six wavelength bands aiding visualisation of colour-dependent atmospheric parameters like water vapour (humidity).

The sounder will contribute in generating vertical profiles of the atmosphere and provide information like temperature and

Navy's MILAN event: Geopolitical scenario, maritime threats will be focus this year, says Vice Admiral Sobti

The Navy has also carried out a series of anti-piracy operations in the Arabian Sea in recent weeks. In the 12th edition of MILAN, the 51 participating countries will be sending their operational units and delegations.

The 16th Finance Commission (XVI-FC) held its first meeting under the Chairmanship of Dr. Arvind Panagariya in Jawahar Vyapar Bhawan, Janpath, New Delhi. The Chairman and Members were welcomed by Secretary, XVI-FC, Shri Ritvik Ranjanam Pandey and other officials of the Finance Commission.

- The Finance Commission normally takes about two years to make their recommendations. As per the clause (1) of article 280 of the Constitution, the Finance Commission is to be constituted every fifth year or earlier
- It is a constitutional body formed by the President of India to give suggestions on centre-state financial relations
- The important tasks of the Finance Commissions are (i)
 To recommend the proportion of the Union tax revenues to be assigned to States and
 Tecommend the share of each State in the assigned tax revenue

North Korea Launches Multiple Cruise Missiles into Sea of Japan, South Korea on High Alert

South Korea Military said that North Korea fired multiple cruise missiles into the Sea of Japan today.
