



RBI keeps repo rate unchanged, raises GDP forecast to 7.2%

The Monetary Policy Committee (MPC) of the Reserve Bank of India (RBI) on Friday decided to keep the repo rate unchanged at 6.5%. tive of achieving the medium-term target for consumer price index (CPI) inflation of 4% within a band of +/- 2% while supporting growth," RBI governor Shaktikanta Das said after the meeting.



- The Monetary Policy Committee (MPC) of the Reserve Bank of India (RBI) on Friday decided to keep the reporate unchanged at 6.5%.
- The MPC has revised its GDP growth forecast upwards from the earlier 7% estimate to 7.2% for the financial year 2024-2025.
- It has also decided to remain focused on withdrawal of accommodation to ensure that inflation does not accelerate, while supporting growth.

With growing instances of digital payment frauds highlighting the need for a system-wide approach to prevent and mitigate them, the Reserve Bank of India (RBI) has proposed to establish a Digital Payments Intelligence Platform for network level intelligence and real-time data sharing across the digital payments' ecosystem.

To take this initiative forward a committee will be constituted to examine various aspects of setting up the Platform.



With the adoption of emandates for recurring payment, transactions have been increasing, and the RBI has proposed to include payments, such as replenishment of balances in Fastag, National Common Mobility Card (NCMC) which are recurring in nature but without any fixed periodicity, in the e-mandate framework.

cial release on Friday said, "Our Consulate in St. Petersburg remains in contact with the university and local authorities. Local emergency services have dies from Volkhov river."

"We offer our condolences to the families. The search for the remaining two missing students continues. The five students involved in the accident belong to the Jalgaon district

of Maharashtra, Our Consulate in St. Petersburg is coordinating with local authorities for the repatriation of the mortal remains," the Ministry stated.

Harshal'sfather, Anant Bhilaji Desalesaid, "On June 4, he had video called us. He said he was taking a stroll by the riverbank with other students . We told him not to venture into the water at that hour. We spoke for 15-20 minutes. The next day on June 5, the university reached out to us saying he was found drowned."

Chinese armed ships patrol around disputed islands, angering Japan

Tokyo: Japan lodged a protest against Beijing on Friday after four armed Chinese coastguard vessels entered waters that Tokyo considers its territory.

The Japanese government said it was the first time that four Chinese vessels carrying what appeared to be cannons had entered its territorial waters in East China Sea around the disputed islands, which Tokyo calls Senkaku and Beijing calls Diaoyu.

"I am not in a position to state

what the Chinese side's intentions are, but the intrusion of vessels belonging to China's coastguard into (our) territory is a breach of international law," Chief Cabinet Secretary Yoshimasa Hayashi told a press conference.

Chinasaid that it had patrolled the waters in armed vessels. It said its patrol was a "routine action" to safeguard sovereignty, and a "necessary step" for peace and stability as well as to counter Japan's recent "negative moves". REUTERS

CONSUMPTION EXPENDITURE ON FOOD IN 2022-23

Households spent most on processed food; Haryana, Rajasthan opted for milk

HOUSEHOLDS ACROSS the country's rural and urban areas spent the highest share on 'beverages, refreshments and processed food' among food items in 2022-23, but some states bucked the trend to favour other items - 'milk and milk products', and 'egg, fish & meat'. In rural areas among all major states, the households of Harvana spent the maximum on 'milk and milk products' at 41.7 per cent as a percentage of total expenditure on food, while Kerala spent the most on 'egg, fish & meat' at 23.5 per cent, detailed report of Household Consumption Expenditure Survey 2022-23 released by Ministry of Statistics and Programme Implementation (MoSPI) on Friday showed.

The trend was not much different in urban areas —Rajasthan recorded the highest expenditure share on 'milk and milk products' at 332 percent, only to be followed by Harvana (33.1 per cent) and
