CPPS gets green light; pensioners to get payments via any bank, branch

The Union Labour Ministry has cleared a proposal for Centralised Pension Payment System (CPPS) for about 78 lakh pensioners under the Employees' Pension Scheme, 1995. The new system enables pension disbursement through any bank, any branch across the country.

Union Minister of Labour and Employment, and Chairperson, Central This facility will
be launched from
January 1, 2025
as part of EPFO's
modernisation project

Board of Trustees, Employees Provident Fund Organisation (EPFO), Mansukh Mandaviya, said the approval of the new payment system was a significant milestone in the modernisation of the EPFO.

The CPPS would ensure

disbursement of pension throughout India without any need for transfer of Pension Payment Orders from one office to another even when the pensioner moves from one location to another, or changes the bank or branch.

'Great relief'

"This will be a great relief to pensioners who move to their hometown after retirement," the Labour Ministry said.

This facility will be

launched as part of EPFO's ongoing IT modernisation project Centralised IT Enabled System (CITES 2.01) from January 1, 2025.

"By enabling pensioners to receive pensions from any bank, any branch, anywhere in the country, this initiative addresses the long-standing challenges faced by pensioners," Mr. Mandaviya said.

Latest ILO study links AI to dip in labour income

Inequality is on the rise as the share of labour income has stagnated worldwide and a large share of youth remain out of employment, education, or training, according to the International Labour Organisation's (ILO) 'World Employment and Social Outlook: September 2024 Update', released in Geneva on Wednesday.

A major reason for this fall in labour income is artificial intelligence or AI, the study stated.

The ILO analysed the impact of technological innovations in the last two decades across 36 countries and said that while these innovations have led to persistent jump in labour productivity and output, they can also reduce the labour income share.

Sounding a warning

"This is consistent with automation-based technological innovations driving the aggregate effects," the ILO said, warning that the absence of a stronger policy response across relevant domains could push

the labour income further down.

To mitigate the potential adverse impacts on inequality, the benefits of technological progress should be widely distributed, the report said.

The report also indicated slow progress on key Sustainable Development Goals (SDGs) as their 2030 deadline approaches.

The study also revealed that the global labour income share, which represents the portion of total income earned by workers, fell by 0.6 percentage points from 2019 to 2022 and has since then remained flat.

It said the COVID-19 pandemic was a key driver of this decline, with nearly

40% of the reduction in the labour income share occurring in the pandemic years of 2020 to 2022.

Plea to take action

"Countries must take ac-

tion to counter the risk of declining labour income share. We need policies that promote an equitable distribution of economic benefits, including freedom of association, collective bargaining and effective labour administration, to achieve inclusive growth," said Celeste Drake, ILO Deputy Director-General.

What do we know about ANIIDCO?

Why has the qualifications of the Andaman and Nicobar Islands Integrated Development Corporation come into question after it got permission to do a ₹72,000 crore mega infrastructure project in Great Nicobar? Does the company have a proper internal environmental governance system?

The story so far:

he Andaman and Nicobar Islands Integrated Development Corporation (ANIIDCO) is the project 772,000 crore mega infrastructure project in Great Nicobar, the southernmost island in the Andaman and Nicobar archipelago. The project entails the construction of a trans-shipment port, a greenfield airport, a tourism and township project and a solar and gas based power plant in Great Nicobar, ANIIDOO which has been granted permission for the mega project is a little known quasi-government agency based in Port Blair.

What do we know about ANHIDCOS ANIIDCO was incorporated on June 28, 1988 under the Companies Act. Its objective is "to develop and commercially exploit natural resources for the balanced and environment friendly development of the territory," Its main activities, according to its website, include trading of petroleum products, Indian made foreign liquor and milk, managing tourism resorts and infrastructure development for tourism and fisheries. The company's average annual turnover and profit over the last three financial years has been ₹370 crore and ₹35 crore. espectively. The corporation's mandate, history, its structure and capabilities raise serious concerns about the process and possible outcomes of making them responsible for such a high profile, high investment and high risk project as the one in Great Nicobar. The 910 sq km island is not just a biodiversity hotspot but also home to indigenous communities. with special rights and is also located in one of the most sectonically active zones.

When the Andaman and Nicobar administration appointed ANI/DCD as

project proponent in July 2020, ANIIDCO neither had an environment policy nor an environment cell. It did not even have the human resources needed to oversee, let alone implement and monitor the project it was tasked to implement. It was only in late 2022 more than two years after it was made the project proponent did it start a process for recruiting people with relevant expertise such as urban planners, environmental planners, architects, infrastructure specialists, and legal and financial experts.

In May, 2021, the Expert Appraisal Committee (EAC) under the Union environment ministry had asked ANIIDCO a number of important questions about its internal environmental governance system. The EAC asked if ANUDCO had a corporate environment policy approved by its board of directors, an

administrative system to ensure compliance with environmental clearance standard operating procedure to deal with environmental and forest violations. ANIIDCO admitted later in August that it did not have an environment policy. The EAC, nevertheless, went ahead and granted environmental clearance to ANIIDCO more than a year later in

What are other conflicts of interests? In 2022, the Mumbai based Conservation. Action Trust had filed a petition before the National Green Tribunal challenging the Stage I forest clearance granted by the Union Environment Ministry, It had pointed out that at the time forest clearance was granted to ANIIDCO, the corporation's managing director was the

Commissioner cum Secretary (Environment and Forests) of the island.

It is clear, the petition noted, that this is "a case of the project proponent certifying itself." Further, it added that the responsibility to assess compliance with the Stage I forest clearance conditions vests with the same authority that has a responsibility to ensure compliance with the conditions. This same pattern was repeated when the Chief Secretary of the islands, who is also the chairman of the board of directors of ANIIDCO, was made a key member of the high powered committee set up by the NGT to look into complaints against the project. ANIIDCO was being allowed to evaluate its own actions again. Numerous persons employed at ANIIDCO in various capacities are currently civil servants with the Andaman and Nicobar administration in charge of environmental and tribal welfare issues. We sent questionnaires to both ANTIDCO and the chairman and secretary of the EAC. None responded.

What have past administrators said? Lt Gen A.K. Singh, Lieutenant Governor of the islands from 2003-16, said that ANIIDCO would be better suited than any other department or organisation in the project, though a project of this dimension would require expert agencies from outside the islands to execute it.

Sanat Kaul, chief secretary of the islands in the early 90s, had critiqued ANIIDCD's tourism operations in a book he wrote in 2015. On the current project, he said 'I don't think ANIIDCO can at all manage a 772,000 crore project unless its upgraded vastly with much better quality staff. If the idea of the government is to use ANIIDCO because it is an existing company fully owned by the government it will need a full revamp from what it was when I was there."

Genome mapping of Chandipura virus: findings

THE GUJARAT Biotechnology Research Centre (GBRC) in Gandhinagar has published the only fully mapped genome of the Chandipura vesiculovirus (CHPV) — the viral infection that caused at least a third of the encephalitis or brain swelling cases in Gujarat during the outbreak in July-August.

What is CHPV?

Apart from encephalitis, CHPV is known of a deadly virus like CHPV, mapping can proto cause fever, headache, convulsions, coma, and even death, usually within days of the symptoms showing up.

CHPV most severely affects children below the age of 15. It can be transmitted by sandflies, ticks, and the Aedes aegypti mosquito which is also the vector for dengue and chikungunya. Sandflies were responsible for this year's outbreak.

- What is Chandipura?
- **Chandipura is a viral infection** that can lead to outbreaks of Acute Encephalitis Syndrome (AES) or brain swelling. It is known to cause fever, headache, and encephalitis leading to convulsions, coma, and death, usually within a few days of the symptoms showing up. The disease's rapid progression is one of its defining features.
- Children who tested positive and died of Chandipura during this year's outbreak reported high grade fever, severe rashes from sandfly bites, convulsions, brain swelling, liver problems, and multi-organ failure usually within 72 hours of symptoms showing up.

WHY INDIA CELEBRATES TEACHERS' DAY ON SEPTEMBER 5

INDIA CELEBRATES Teachers' Day annually on September 5, the birth anniversary of former President Sarvepalli Radhakrishnan (1888–1975). Here is why.

Philosopher of Hinduism

One of India's most recognised and influential thinkers of the 20th century, Radhakrishnan's life and work was dedicated to defining, defending, and disseminating the Hindu religion. He is seen in philosophy circles as a bridge-builder between India and the West, and credited for his role in shaping the West's understanding of Hinduism.

Radhakrishnan was among the foremost proponents of the non-dualist Advaita Vedanta tradition in the 20th century, and re-interpreted Adi Shankara's philosophy for modern times. In doing so, he defended Hinduism against what he said was "uninformed Western criticism".

Respected teacher

By the 1920s, Radhakrishnan had established himself as one of India's most respected academics. He held the prestigious King George V Chair at the Calcutta University from 1921 to 1932, was the second vice-chancellor of Andhra University from 1931 to 1936, and the fourth vice-chancellor of Banaras Hindu University from 1939 to 1948. He also held the Spalding Chair of Eastern

Religion and Ethics at University of Oxford from 1936 to 1952. Radhakrishnan was knighted in 1931.

Radhakrishnan was also a brilliant teacher, who developed deep personal bonds with students. He thought highly of the profession of teaching, and is recorded as having said several times that "teachers should be the best minds in the country".

He became the first Vice President (1952-62), and the second President of India (1962-67). In 1962, after he became president, some old students expressed their wish to celebrate his birthday. Radhakrishnan refused a personal celebration, and instead requested his students to honour teachers across the country on his birth anniversary.

Thus began the tradition of celebrating Teachers' Day on September 5. ENS
