Health department reported 178 chikungunya cases as of August 31, surpassing figures from previous years; no updated data, however, has been released in the past three months, leaving the current situation unclear

A lowdown on notice

The advisory, issued on November 8, reflects growing concerns over the spread of vector-borne diseases in the region





- The U.S. Centers for Disease Control and Prevention (CDC) issued a 'Level 2' travel advisory for Telangana due to a higher-than-expected number of chikungunya cases among U.S. travelers. The advisory, released on November 8, urges enhanced precautions2. This follows a similar alert in August for a Zika virus outbreak in Maharashtra. The CDC's travel advisory system has four levels, with Level 2 calling for enhanced precautions.
- Chikungunya is a disease transmitted to humans by mosquitoes in Africa, Asia, and the Americas; sporadic outbreaks have been reported in other regions.
- Dengue and Zika have similar symptoms to chikungunya, making chikungunya easy to misdiagnose.
- Chikungunya causes fever and severe joint pain, which is often debilitating and varies in duration; other symptoms include joint swelling, muscle pain, headache, nausea, fatigue and rash.

CJI recuses himself from hearing case on felling of trees in Delhi's Ridge

Chief Justice of India Sanjiv Khanna on Monday recused himself from hearing a case involving illegal felling of trees in Delhi's protected Ridge area, in which Lieutenant Governor V.K. Saxena has filed an affidavit in the Supreme Court in his personal capacity on his role in the felling of trees. The L-G is ex officio Chairperson of Delhi Development Authority (DDA).

The CJI, after a brief interaction with his Associate Judge on the Bench Justice Sanjay Kumar, explained that when he was the Chairnerson of National Local situation and would allocate a Bench accordingly. The case was listed for hearing in the week commencing on December 2.

A crucial question surrounding the L-G is whether he knew that trees in the Ridge area could not be felled without prior permission from the top court.

There is also the question of when exactly he had come to know that the trees were felled illegally in the area. On October 24, a three-judge Bench led by then Chief Justice of India D.Y. Chandrachud had orally observed that this particular detail in Mr. Saxena's personal affidavit did not

- Conflict of Interest: Judges may recuse themselves if there's a conflict of interest (e.g., financial interest, personal relationships).
- A judge must avoid situations where their impartiality might be questioned (e.g., past judgments, associations with parties involved).
- Nemo judex in sua causa: No one should be a judge in their own case.
- Justice Must Be Seen to Be Done: Principle established in Rex v. Sussex Justices (1924), ensuring justice is not only done but appears to be done.

India's GSAT-N2 (GSAT-20) communication satellite was successfully launched by SpaceX's Falcon-9 rock et in the early hours of Tuesday.

After lifting off at 12:01 a.m. (Indian Standard Time) from the Space Launch Complex 40 (SLC-40) at Cape Canaveral Space Force Station in Florida, Falcon-9 put the GSAT-N2 into a geosynchronous transfer orbit.



African penguins, listed 'endangered', seek peace, food

- In October 2024, the African penguin was classified as critically endangered by the International Union for the Conservation of Nature, marking a significant concern for Africa's only penguin species.
- The decline of African penguins (Spheniscus demersus), which are native to Namibia and South Africa, has been ongoing since the 1800s due to activities like egg harvesting, guano collection, and habitat destruction.
 While such practices have ceased, the penguins' main threat since the early 2000s has been a lack of prey, exacerbated by climate change, industrial fishing, and a 70% population decline from 2000 to 2024.

Strictest stage of emergency measures to combat air pollution in the National Capital Region

HE SUPREME Court questioned the Delhi pvernment on Monday over the "delay" n implementing stage IV of the Graded esponse Action Plan (GRAP). With smog nd high levels of air pollution in Delhi-ICR on Sunday, the Commission for Air Juality Management (CAQM) had issued lirections for implementing stage IV from Aonday morning onwards.

However, the court said the CAQM subommittee tasked with operationalising he GRAP was supposed "to take preempive steps", before pollution levels approach he specific threshold. The Air Quality Index AQI) was 441 at 4 pm on Sunday, and reached the 450 threshold at which GRAP V is supposed to be implemented later in he evening. The apex court has said that tage IV measures should continue even if he AQI drops below 450 in Delhi-NCR.

What is GRAP?

GRAP is a set of emergency measures hat kick in to prevent further deterioraion of air quality once it reaches a certain hreshold in Delhi-NCR. Approved by the upreme Court in 2016, and notified in 017, the plan was formulated after sevstage II is when it's in the 'very poor' category (301-400), stage III is when the AQI is the 'severe' category (401-450) and finally stage IV is when it rises to the 'severe +' category (more than 450).

Why was GRAP IV imposed?

The sub-committee's decision was based on a review of the air quality in Delhi-NCR, and forecasts for meteorological conditions. An official notification said air quality will likely remain in this adverse range in the next few days owing to heavy fog, variable winds, and highly unfavourable meteorological and climatic conditions.

Stage I, stage II and stage III restrictions were imposed on October 14, October 21 and November 14, respectively.

And what does GRAP IV say? Some key directions include:

Ban on the entry of truck traffic into Delhi (except for trucks carrying essential commodities/providing essential services). All LNG/CNG/Electric/Bharat Stage-VI diesel trucks are, however, permitted to enter.

Light Commercial Vehicles (LCVs) registered outside Delhi, other than EVs/CNG/BS-VI diesel, cannot enter Delhi, except those carrying essential com-



The Supreme Court questioned the Delhi government on November 18 about the delay in implementing Stage IV of the Graded Response Action Plan (GRAP) due to high pollution levels. Despite the Air Quality Index (AQI) hitting 441 on Sunday, Stage IV should have been implemented preemptively.

GRAP Overview:GRAP is a set of emergency measures activated at various air quality thresholds in Delhi-NCR. Stage I (AQI 201-300), Stage II (AQI 301-400), Stage III (AQI 401-450), and Stage IV (AQI >450).

Current Implementation:

Reason: Delhi's AQI breached the severe threshold,

requiring immediate action.

Measures under Stage IV:

Ban on truck traffic into Delhi (except essential services). Ban on non-CNG/BS-VI diesel Light Commercial Vehicles (LCVs) and diesel-operated Medium/Heavy Goods Vehicles (MGVs/HGVs).

Ban on construction and demolition activities for public projects.
