

Sanjay Malhotra Appointed As New RBI Governor





News

• The Appointments Committee of the Cabinet (ACC), headed by Prime Minister Narendra Modi has approved Sanjay Malhotra's appointment as the next governor of the Reserve Bank of India (RBI).

About: RBI Governor

- Appointment: The governor is appointed under the provisions of the Reserve Bank of India Act, 1934.
- Term: The Governor shall hold office for such term not exceeding five years as the Central Government may fix when appointing them, and shall be eligible for reappointment.
- Qualification: The RBI Act, of 1934 does not mention any specific qualification for the governor. People with different educational backgrounds were selected to head the institution. However, the governor traditionally is either a civil services personnel or an economists.

About: Human Rights Day

- It is observed on 10th December every year to commemorate the Universal Declaration of Human Rights (UDHR), which was adopted and proclaimed by the United Nations General Assembly in 1948.
- The UDHR embodies the principle that all human beings are born free and equal, with the right to life, liberty, and security, equality before the law, and freedom of thought, conscience, religion, opinion, and expression.
- This principle is also reflected in India's Constitution and the Protection of Human Rights Act (PHRA), 1993, which provided the legal framework for the establishment of the National Human Rights Commission (NHRC), India on 12th October, 1993.

PM launches LIC's 'Bima Sakhi Yojana'

Prime Minister Narendra Modi on Monday launched the 'Bima Sakhi Yojana' of LIC here under which two lakh woman insurance agents will be appointed over the next three years.

'Bima Sakhi Yojana', an initiative of State-owned LIC, is designed to empower women aged 18-70 years who are Class X pass.

The women agents will receive specialised training and a stipend for the first three years to promote financial literacy and insurance awareness.

Under the scheme, the woman agents will also get

a stipend of ₹7,000 per month for the first year, ₹6,000 per month in the second year and ₹5,000 per month in the third year. Bima Sakhis will also get the benefit of commission.

The plan is to appoint two lakh Bima Sakhi over a period of three years.

About: LIC's Bima Sakhi Yojana


- It is designed to empower women aged 18-70 years, who are Class X pass.
- They will receive specialized training and a stipend for the first three years to promote financial literacy and insurance awareness.
- The scheme offers a total stipend of ₹7,000 per month to each candidate in the first year, ₹6,000 per month in the second year and ₹5,000 per month in the third year.
- Over and above, bima sakhis can also earn commission for selling LIC policies.

 The Opposition INDIA bloc is set to bring a no-confidence motion against Rajya Sabha Chairman and Vice President Jagdeep Dhankhar under Article 67(B) of the Indian Constitution.

About

- Article 67 of the Constitution says that the Vice-President may be removed from office with a resolution passed by a majority of members in the Rajya Sabha.
- The House of the People or the Lok Sabha has to agree to the resolution as well.
- The resolution, however, should be moved with at least 14 days' notice.

About: Golden Globe awards

- It is given by the Hollywood Foreign Press Association (HFPA) to recognize excellence in both American and international film and television.
- It generally ranks as the third most-watched awards show each year, behind only the Oscars and the Grammy Awards.

Indian Recipient

- Music composer AR Rahman was the first Indian to win a Golden Globe in Best Score category in 2009 for the British film 'Slumdog Millionaire.
- 'RRR' won the Best Original Song for 'Naatu Naatu' in 2023. It is the first Indian film to win at the Golden Globes.
